

Trip Chic!

General conditions about reservation and rental

1. - The minimum rental period is 24 hours. In case of client request, it can be rented for less time but the price will remain the daily tariff.

In case the contractor does not deliver the vehicle at the agreed time and date, the contractor authorizes Trip Chic! (Sandra Gascón) to charge the amount of 20,00 € for every hour of delay respect to the agreed deliver time and in the case that there is any additional damage to Trip Chic! about the inability of delivering the same vehicle to another client, the lessor will charge the import related to this damage, moreover the vehicle has to be deliver to the central office of Trip Chic!

2.- The entire rental import will be paid by the client in the moment of the delivery of the vehicle.

3.- The contractor is not allowed neither subrogate, nor to sublease the vehicle to any other person without the expressed and written permission from Trip Chic! (Sandra Gascón).

4.- Vehicle condition. In the moment of the delivery of the vehicle and its accessories, the contractor recognizes that the Vespa and its accessories are in perfect operating status and has been provided with the copy of the vehicle insurance documents and certification, which have to be shown anytime they are requested by the authorities.

The contractor commits to return the vehicle (paragraph 1) with the documentation and the accessories in perfect operating status due to the proper use during the utilization time.

The contractor takes the responsibility of the vehicle and the proper use of it and commits to the charge of damages derived from bad use and the damages due to accidents which are not covered from the third party insurance policy included in the vehicle.

5. - Traffic violations. The contractor takes the responsibility of traffic violations which are committed with the vehicle during the rental period. To drive under the effect of alcohol and/or narcotics with superior rates to the spanish legislation will make the contractor the only responsible for the damages caused to the vehicle and/or to third party. Trip Chic! will claim the consequent indemnities of the damage caused to the company because of this reason and similars.

6. - Accident or theft. In the case that the vehicle is involved in an accident, the contractor is obliged to inform immediately Trip Chic! (Sandra Gascón) calling the number + 34 650 16 77 27 by giving a detailed report of the accident, as well as inform the police and provide Trip Chic! the police statement. In case of disappearance or theft of the vehicle the contractor is obliged to report it to the police and Trip Chic! (Sandra Gascón) (cell. + 34 650 16 77 27) as soon as possible and provide a copy of the report made with the police.

7.-Deposit. The vehicle has a mandatory third party insurance which covers damages to third parties, included passengers and the driver, but does not cover damages to the vehicle. The contractor will provide a credit card number to cover the total reparation or substitution of the vehicle in case of damages, accident or theft. In case of theft or accident the contractor is obliged to pay to Trip Chic (Sandra Gascón) the import corresponding to the market value of the vehicle at the moment of the sinister.

The contractor will give a deposit of 400,00 € at the moment of the delivery of the vehicle in concept of guarantee and the import will be totally returned in the same form of payment, if the vehicle, the documentation and its accessories are returned in perfect operating status and in the conditions derived from the proper use during the rental time.

In case that the contractor does not give back the gasoline tank full, it will authorize Trip Chic (Sandra Gascón) to charge from the credit card the sum of 15,00 € for its replacement.

9.- Destination. The vehicle can be driven in the city of Madrid, the client takes the responsibility, in case of utilization outside the established limits by the orbital road M-50. In case of utilization outside the orbital road the contractor is the only responsible for any damages of the vehicle and third parties.

10.- To drive a motorbike and/or a moped implies risk and requires skills by managing it, therefore the contractor declares to have them and the necessary documentation in order to drive legally a rented vehicle in Spain.

The contractor exempts Trip Chic! from any responsibilities in case of accident.

Trip Chic! reserves the right of refusing the rental service to people that shows visible signs that do not accomplish the psychophysical characteristics, inebriation or the effect of use of not allowed narcotics, without incurring any discrimination in the performance of the service.
